- 3. Changes or additions to the agenda (All Trustees). Addition of barking dogs in Community, and Smith House
- **4. Secretary Report** (Tebbing). Randy presented the November 2, 2020 meeting minutes. Jim W. motioned to accept minutes and Garrett S. seconded. Board so moved.
- 5. Treasurer Report (Hollenbaugh). Dave Hollenbaugh provided Nov'20 financial report. Pointed out some noteworthy deltas from last year including lost Community Building rental revenues due to COVID. Dave H. is talking to propane companies to bid prices for service. Due to mowing service fees being above budget, Board is planning to review for invoices for 2021 planning purposes to see if budget needs revised or a budget cap implemented.
